If you receive a rejection due to PA, step-edit, or NDC block, submit Other Coverage Code of **3** (Secondary Claim). The patient's out-of-pocket expense will be reduced up to \$75 for a 30-day supply OR up to \$150 for a 90-day supply, the maximum savings limit for the program.
